PHYSICAL THERAPIST ASSISTANT

- Standard #1: Physical therapist assistants shall respect the inherent dignity, and rights, of all individuals.
- Standard #2: Physical therapist assistants shall be trustworthy and compassionate in addressing the rights and needs of patients.
- Standard #3: Physical therapist assistants shall make sound decisions in collaboration with the physical therapist and within the boundaries established by laws and regulations.
- Standard #4: Physical therapist assistants shall demonstrate integrity in their relationships with patients, families, colleagues, students, other health care providers, employers, payers, and the public.
- Standard #5: Physical therapist assistants shall fulfill their legal and ethical obligations.
